


### **GDP** Projection

#### **GDP&Electricity Demand**\*



Ranking second in the World after China, and first in Europe.






## **Energy Dependency**

#### **Current Situation**


- ▶ %72 Energy dependency

## Why is Turkey Late on Nuclear?

Date	Events
1956	Atomic Energy Authority established
1967-1972	2nd part of five years nuclear development plan failed.
1972	TEK Nuclear Energy Department Established
1976	Akkuyu site licence accepted.
1977-1979	The tender cancelled
1983-1985	The tender cancelled
1986	TEK Nuclear Energy Department closed.
1996-2000	The tender canceled after 8 delays.
2007	National Nuclear Technology Development Program started
2007	Law No. 5710
2008-2009	The tender cancelled
2010	IGA signed with the Russian Federation Akkuyu NGS Electricity Generation Company established
